3 Matters Arising

3.1 Police report

PCs Spence and McDonald reported

- No crime statistics have been made available to them. (it was noted that statistics were also not reported in April, despite an agreement for consistent reporting across Edinburgh since June 2016.)
- There was recently a major incident on Lindsay Road a suspect has been arrested and is on remand.
- There was recently a stabbing on Rossie Place a suspect has been arrested.
- Operation Mondana is countering doorstep crime/bogus workmen across Scotland.
- Operation Rigoleto was a re-organisation of community policing. The largest part of this was a reduction in CPO numbers, but it enabled CPOs to actually do community work
- The number of calls about boy-racers has decreased. A road safety assessment carried out by CEC has led to no changes to roads. <u>ACTION: CLLR BOOTH TO LOOK INTO ROAD ASSESSMENT ACCURACY</u>
- Concerning the 20mph speed limits, police officers are educating and enforcing as needed. There is at least 1 radar speed-gun per Edinburgh police station in Edinburgh.

The PCs were invited to attend a residents' association meeting (8 June)

3.2 Waterfront plaza and other planning matters

- J Marlborough reported that that the waterfrontplanning application is at a standstill it was withdrawn from Development Management Sub-Committee on 2017_03_19 due to (1) allow further consideration of how to proceed; (2) transport issues; (3) high planning authorities wanting shops in main block. Hence Cala is deciding whether to continue with the application as-is, submit a revised application or withdraw altogether. The next opportunity for CEC to consider this application is 7 June.
- Planning permission for the **hotel** now out of date, but the site still being advertised for sale.
- The **boardwalk** is now operational. Planning Application 17/01081/FUL for 'Wheeled Indoor Sports Facility' in Ocean Terminal (the former BHS site) has been granted temporary change of use of Unit 2 for period of three months.
- The 'Skyliner' Rettie/Taylor-Wimpey site is for sale (Brochure emailed 2017_03_02). The closing date for this sale was 2017_03_30 but there is still no evidence of as ale on site.
- Malt & Hops application will be considered at CEC's Development Management Subcommittee on 7 June, following a site-visit on 5 June (if this committee is formed in time).

3.3 Place-making with older people

Dr Woolwich presented as follows

- He is an associate professor at Heriott-Watt University, investigating how cities and communities can be better designed to support aging populations. The current 3-year project, started in May 2016, has 2 aims:
 - o To understand how older people experience aging within their communities
 - o To make recommendations on how 'age-friendly cities' and 'age-friendly services' can be developed.

- There are some 'age-friendly cities' in the UK, including Edinburgh and Manchester. These cities are not
 necessarily currently age-friendly but have committed to identify what they can do at local levels to support
 older people. Such measures include making housing and transport suit older people, building respect and
 social inclusion, reducing causes for social exclusion, improved health and social care delivery.
- It has been noted that some age-friendly features also suit other people. For example dropped kerbs suit prams and wheelchairs. Hence the project asked local authorities whether they are asking older people what they want the basic response was 'very little'.
- The project has chosen 3 case-study cities: Edinburgh, Manchester and Glasgow. Within Edinburgh, it is studying Leith, Morningside and Craigmillar. Leith and Craigmillar have been assessed as having strong senses of community.
- The project is trying to gather data from as many over-60-year-olds as possible. (>60 was chosen by the WHO as the definition of 'older'.)
- Quantitative survey data on living in Leith has already been collected. From this, some priorities have been developed. Researchers are now gathering qualitative data via interviews etc they have collected research subjects via community organisations, care organisations and follow-ups to 'door-knocks'. The researchers want to speak with people having a range of ages >60.
- It has been found that green space and the quality thereof is very important. Similarly, intergenerational communities are important older people do not want to be ghettoised.
- It has been difficult to contact certain groups, such as other ethnic groups. Language barriers can impede access to and take-up of government and other social services. Hence researchers are asking people to capture images, and are using family members as interpreters.

It was suggested that the project could obtain data from recent CEC consultations, and that recommendations could include actions for private organisations, not just CEC. It was suggested that currently local authority budgets for community actions are quite small, and that CEC should have a 'champion' for older people.
